**MINUTES OF THE 83<sup>rd</sup> MEETING OF EMPOWERED COMMITTEE UNDER MULTI-SECTORAL DEVELOPMENT PROGRAMME HELD ON 12<sup>th</sup> FEBRUARY, 2014 UNDER THE CHAIRMANSHIP OF SECRETARY, MINISTRY OF MINORITY AFFAIRS.**

The 83<sup>rd</sup> Meeting of the Empowered Committee (EC) for Multi-sectoral Development Programme (MsDP) was held on 12<sup>th</sup> February, 2014 under the Chairmanship of Secretary, Ministry of Minority Affairs, to consider and approve the project proposals with regard to the Minority Concentration Blocks (MCBs)/Minority Concentration Towns (MCTs) received from State Governments of Manipur, Karnataka, Uttarakhand and West Bengal. The representatives of Deptt. of Drinking Water and Sanitation, Ministry of Women & Child Development and the officials from the State Governments attended the meeting. The officials from State Governments also attended the meeting through video conferencing. A list of officials present in the meeting is annexed as annexure - I.

2. **Progress on website:** The progress of implementation of MsDP is reported on quarterly basis to the Delivery Monitoring Unit (DMU) in PMO (Prime Minister's Office) and the status of implementation of various projects in terms of funds released by the Ministry of Minority Affairs and utilized by the State/UT; number of works sanctioned, completed and works in progress is regularly monitored. These details and photographs of works are placed in the Ministry's website for transparency. State Governments/UT Administrations are required to review the implementation on quarterly basis; ensure that Central funds are released to the districts within one month of sanction; State share (wherever applicable) released along with the Central funds; ensure that the executing agencies start the construction works at the earliest, and complete the construction works within the scheduled period. A computer software application called MIS-MsDP has been made operational in July, 2011 and the States/UT have been advised to ensure that data is entered by all concerned so that Quarterly Progress Report (QPR), utilization certificate and various progress reports is generated through the software.

3. **Adhering to guidelines and eliminating duplication:** States/UTs should ensure that the proposals sent have the approval of the State Level Committee of MsDP / mission director of CSS concerned in order to ensure that the proposal, in terms of specification, norms, standards etc., is in accordance with the guidelines of the scheme concerned and that duplication has been ruled out. The responsibility for eliminating duplication of work and



avoiding double counting of a scheme under two funding sources vested with both the district authority and the State Government. Accounts under MsDP should be maintained separately and Central Ministry concerned informed of assets created in respect of CSS topped up under MsDP.

4. **Centrally Sponsored Scheme (CSS) guidelines:** MsDP provides that there would be no change in guidelines of any existing Centrally Sponsored Scheme (CSS) under implementation in such districts for which this programme would provide additional funds. In case schemes for individual benefits are taken up under the programme, there shall be no divergence from existing norms for selection of beneficiaries from the list of BPL families in the district, so that benefits from the additional funds flow to all BPL families and not selectively. However, the provision under Indira AwasYojana (IAY) guidelines for making separate allocation for Scheduled Castes (SC) or Scheduled Tribes (ST) will not be followed under MsDP. The entire number of units sanctioned under MsDP would be given to BPL households, from minority communities as well as other communities, in order of the serial number in the approved wait list without making separate allocation for Scheduled Castes (SC) or Scheduled Tribes (ST).

4.1. **Aganwadi Centre:** Where ever Aganwadi Centre has been approved, it should be ensured to follow the norms of Ministry of Women and Child Development that the minimum area of AWC would be 600 sq. feet with a sitting room for children/women, separate kitchen, store for storing food items, child friendly toilets and space for children to play, with drinking water facility.

5. **Timely release of funds:** The sanction letters of the Ministry stipulate that funds should be released to the district/implementing agency within a month's time, but the States/UT have been generally taking much time in releasing funds to the district/implementing agency. State shares, wherever applicable, are not released along with the Central funds by some States. Prompt release of funds was advised to ensure that works are started at the earliest.

6. **Utilisation Certificate:** For release of second installment, utilization certificate (UC) is required. If the UC is furnished within a period of one year after release by the Ministry, 60% UC would be required for releasing the next installment. However, if utilization is made beyond the period of a year, 100% utilization would be necessary. The UCs would need to be accompanied by QPR showing physical progress, photographs as proof of the work in progress and the phasing of funds for the release sought. The Utilization Certificates of the 2<sup>nd</sup> instalment should also be submitted by the States/UTs to the Ministry.

7. **Sample testing and quality control:** Quality control was to be ensured through regular and frequent field visits and by testing samples of the construction work for which

funds would be sanctioned by the Ministry on receipt of request from the State concerned. All the States/UTs were advised to carry out field visits, quality control tests and review all works under MsDP to ensure that the shortcomings do not take place in their State/UT.

8. **Inclusion of Members of Parliament in State and district level committees:**

Members of Parliament (MP) and Member of Legislative Assembly (MLAs) have been included in the State and district level committees for implementation of the Prime Minister's New 15 Point Programme for the Welfare of Minorities which also serves as the committee for MsDP. MLAs are also to be nominated on the Committees by the State Government. It should be ensured that they are invited to attend the meetings of the district and State level committees.

9. **Display boards:** Para 19 of the scheme of MsDP provides for a 'display board' which should have- Name of the project/scheme printed followed by "Multi-sectoral Development Programme (MsDP), Ministry of Minority Affairs, Govt. of India." For projects with longer construction period, in addition to above, the name of implementing agency, date of sanction of the project, likely date of completion and estimated cost of the project should be printed on the display boards. States/UT should ensure this and put up a permanent display on completion of each project.

10. **General conditions applicable to projects approved by the Empowered Committee**

For approvals given by the Empowered Committee, including in-principle approvals, the Principal Secretary/Secretary of State's/UTs and the District Collectors/representatives were advised to note that the following conditions would apply to all projects under MsDP. State Government/UT administration concerned should ensure that the following have been complied with:-

**Approval of the State department concerned/Mission Director** for Centrally Sponsored Scheme (CSS) concerned have covered the following –

- (a) **Need** for having the proposal sanctioned under MsDP.
- (b) **Duplication has been eliminated.**
- (c) Proposal is as **per norms, specifications, layout design, funding norms and cost norms of the CSS guidelines** concerned.
- (d) **Separate accounts for schemes under MsDP will be maintained** and details sent to the Central Ministry concerned for maintaining proper record of assets and avoiding double counting and duplication.



- (e) **Estimates have been prepared as per Schedule of Rates (SOR)** of the State Government and have been **approved by a competent engineering department** of the State Govt.
- (f) **Staff is available** for functioning unit or will be provided for new unit.
- (g) **Recurring expenditure** would be provided by the State Government.
- (h) **Land is available and/or will be made available by the State Government in villages/locations having the highest proportion (percentage) of minority population.**

11. **Review meetings of Oversight committee in State, and State and district level committees:** The scheme of MsDP envisages quarterly review meetings by the State and district level committees for implementation of the Prime Minister's New 15 Point Programme for the Welfare of Minorities which also serves as the review committees for MsDP. The State level committee also acts as the Oversight Committee for MsDP. Quarterly review meetings for State level committee/State Oversight Committee and district level Committee should be held and copy of the meeting notice should be sent to the Ministry to enable a representative to attend State Level meetings as envisaged under MsDP. It should be ensured that Members of Parliament nominated in such Committees are invited to attend the meetings.

12. **Photographs:** Photographs of completed works and works in progress indicating type of asset, name of location/village and date should be placed in the MIS-MsDP web page and officials from the State and districts were impressed upon the need to have photographs, in digital format sent by email to **Shri U.K. Sinha, Under Secretary in the Ministry- [ujjwal.sinha@nic.in](mailto:ujjwal.sinha@nic.in)** . The photographs are required for release of second installment.

13. The Chairman (EC) emphasized that the benefits accrued by the implementation of MsDP should go to the Minority Communities properly. Therefore, not only location of the assets in the areas having substantial minority population is important, but it is also equally important to see that the assets created are actually imparting benefits to the minorities. The State Government was impressed upon to propose the locations of projects under MsDP accordingly.



## Item No. (A) Manipur

14. The Government of Manipur has submitted project proposals in respect of Churachandpur, Senapati and Imphal East districts of Manipur. The Minority Concentration Blocks (MCBs) namely Samulamlan, Henglep T.D., Singngat T.D, Thanlon T.D, Parbung T.D, Kangpokpi T.D, Saikul T.D, Saitu Gamphazoi T.D and Imphal East CD- block were considered in the Empowered Committee for implementation of MsDP during 12<sup>th</sup> Five Year Plan. The State Government has also furnished the following information with the proposal:

- i. Land availability is confirmed.
- ii. All works will be implemented by DRDA, Churachandpur
- iii. The Cost estimates proposed for different works/projects are as per the standardized cost derived on the basis of norms/ design prescribed by the concerned Ministry for that particular work
- iv. No duplication of the work with any Scheme of the Central/State Government and concerned Director/Mission Director has been consulted in this regard.
- v. Maintenance and recurring cost related will be borne by the concerned department of State Govt.
- vi. The plan proposal has been approved by the State Level Committee for PM's New 15 point programme.
- vii. It has been ensured that all locations proposed have atleast 25% minority population.

### a. Churachandpur District:

Deputy Commissioner of Churachandpur district clarified the following during the meeting:

- i. Proposed works under MSDP are being constructed / located within the premises of Government holdings.
- ii. The SSA/RMSA pattern is being followed in case of construction of School building, Additional classrooms and hostels.
- iii. All the schools proposed are running schools and don't have their own building. They are running in other places like community hall, church hall or in rented buildings.
- iv. The NRHM norms are being followed in case of construction of Primary Health Centres and Primary Health sub Centres.
- v. The hostel is only for girls with the capacity of 44 beds only and attached to Government schools.
- vi. Also clarified that RCC type of building means a structure with RCC walling and CGI roofing.
- vii. Estimates have been prepared as per SOR.

The Govt. of Manipur has included 5.6% local sale taxes and 3 % for contingency charges in their estimated cost. The EC did not agree to these costs. It was decided to revise the cost deducting the taxes.



The EC considered the project proposals submitted by the State Government of Maipur in respect of 5 Minority Concentration Blocks (MCBs) of Churachandpur Districts namely, Samulamlan, Henglep T.D., Singngat T.D, Thanlon T.D, Parbung T.D and decided to approve the projects as given below subject to the terms and conditions mentioned in the minutes, and also decided to release the 1<sup>st</sup> installment maximum upto 50% of the Central share for implementation of the projects so approved:-

**i. Churachandpur Block:**

Status of proposals of Churachandpur block was discussed and the DC present in the meeting proposed to submit the revised proposal.

**b. Senapati and East Imphal Districts:**

EC observed that the proposed projects for the Minority Concentration Blocks of Senapati and East Imphal Districts largely relate to Community Toilet, Drinking Water, Market shed, IAY, and Construction of Rural farmers Service which are not covered under the priority sectors of MsDP. The identified priority sectors which are the felt need of minorities have been overall neglected in the project proposals prepared for blocks and towns.

EC requested the State Govt. to send the revised project proposals keeping in view the mandate and guidelines of MsDP so that the programme for minority welfare is implemented in an effective way in the State.

**Item No. (B) West Bengal**

A proposal received from Govt. of West Bengal on Skill Development was examined in 80<sup>th</sup> EC meeting. During discussion it was clarified by EC that training should be either carried out in the govt. institutes or, for partnering with private institutes the selection of such institutes is to be done through a transparent process through advertising in the newspapers and website.

A revised proposal based on the discussion held was received in respect of Govt. Skill training organizations and considered by the EC in this Meeting. The EC found the proposal in order. However, the EC again reiterated the condition that:

- i. The proposed Training will be conducted for Modular Employable Skills (MES) which are approved by National Council of Vocational Training (NCVT). The duration of the training would be as indicated under MES and the cost indicated by DGET would be taken as benchmark.
- ii. The institution would ensure that 75% of the trained candidates would get placement. The EC did not agree for 2% as contingency cost, 5% as monitoring cost and 3% as establishment cost.

The EC considered the project proposals in respect of Minority Concentration Blocks (MCBs) of 12 districts namely, Birbhum, Burdwan, Murshidabad, Nadia, Cooch Behar, North 24 Paragana, South 24 Paragana, Uttar Dinajpur, Dakshin Dinajpur, Malda Howrah and Darjeeling of West Bengal identified for implementation of MsDP during 12<sup>th</sup> Five Year Plan under restructured MsDP and decided to approve the projects as given below subject to the terms and conditions mentioned in the minutes, and also decided to release the 1<sup>st</sup> instalment maximum upto 50% of the central share for implementation of the projects so approved.

### Item No. (C) Karnataka

The EC took note of the following information furnished by the State Govt. regarding availability of land, cost etc. as given below:

- i. (a) It has been ensured that all the locations proposed have at least 25% minority population in its catchment area.  
(b) It has been ensured that all the school where ACRs, Labs and Hostels are proposed have at least 25% enrolment of the minority students.
- ii. The cost estimates proposed for the different works/projects are as per the standardized cost derived on the basis of norms/design prescribed by the concerned Ministry for that particular work.
- iii. It has been ensured that there is no duplication of the work with any scheme of the central Government or a state Govt. and the concerned Director/Mission Director has been consulted in this regard.
- iv. The land for all the construction activities is available.
- v. The maintenance and the recurring cost related to the assets proposed in this plan will be borne by the State Government.
- vi. The plan proposal has been recommended by the State Level Committee for PM's 15 Point Programme.

Subsequently, the State Govt. also submitted following clarifications regarding proposal:-

**Community Library:** It was clarified by the State that the Community Library will not only be used as a library but also as a study centre after school hours. It can be used for giving coaching/training for competitive examinations to the minority students. The libraries will function under the District Library Management.

**Construction of ITI:** The State Govt proposed to construct ITI with different cost in Sindhanur Town in Raichur District, in Bagalkot and Jamakhandi town in Bagalkot district, in Koppal and Gangavati town in Koppal district and in Hospet Town in Bellary District. However the State has not submitted the details of trades and cost relating to ITI. The construction of ITIs was agreed to by the Empowered Committee in principle, and State Govt was directed to submit the details about ITIs. The State was further advised to prepare the proposal of ITI as per the norms of NCVT.

**Skill Development:** The proposal submitted by the Govt. of Karnataka for Skill development Programme for minorities was discussed at length. The EC observed that the agencies for skill training should be selected in a transparent manner keeping in view their manpower, capacity of training, organizational structure and links with the industries for



placement of skilled condition. EC requested the State Govt. to follow the guidelines given in this Ministry's DO letter no 3/31/2012-PP dated 28/01/2014.

The EC further observed that the selection of trades and duration of training etc. should be as per norms of DGET. After training, the candidate should be given certification by an organization recognized by the NCVT for this purpose. The training should also guarantee 75% employability of the trained candidates. The State Govt. assured to address the issues and send proposal again.

The EC considered the project proposals submitted by the State Government of Karnataka in respect of 03 Minority Concentration Blocks (MCBs) and 08 towns of all the identified District of Karnataka for implementation of MsDP during 12<sup>th</sup> Five Year Plan under restructured MsDP. EC decided to approve the following projects, subject to the terms and conditions mentioned hereinabove, and also decided to release the 1<sup>st</sup> installment maximum upto 50% of the Central share for implementation of the projects so approved.
