In continuation to this Ministry's sanction letter of even number dated 31.12.2014 & 31.08.2015 & 22.02.2017 I am directed to convey the sanction of the President for release of total amount of Rs. **3,19,02,000/- (Rupees Three Crore Nineteen Lakh Two Thousand only)** as 2nd instalment for the year 2014-15 , 2015-16 & 2017-18 to the Govt. of Rajasthan for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Districts" for Alwar District as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Rajasthan through CAS, Reserve Bank of India, Nagpur.

The expenditure is debitale to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 49 - Multi sectoral Development Programme for minorities, 49.00.35 Grant for creation of capital assets the year 2017-18.

3. **The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.**

4. A copy of the Utilization certificate of 1st installment is enclosed. Further it is certified that no UC is pending for this project




