Subject: Grant in aid for engagement of Block Level Facilitators(BLFs) under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Blocks to Government of Sikkim.

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs. 3,60,000/- (Rupees Three Lakh Sixty Thousand only) to the Govt. of Sikkim for engagement of Block Level Facilitator(BLF) each in 2 MCBs (Mangan and Chungthang) of North Sikkim district in the State of Sikkim. The sanction amount includes monthly remuneration of BLF (@Rs. 10,000 per month) and expenses towards TA/DA (@Rs. 5000/- per month) for 12 months from the date of joining of BLFs, in terms of Para 14 of the guideline on restructured MsDP and letter no. 3/31/2012-PP dated 19.8.2013 of this Ministry. The non-recurring grant may be released to the Govt. of Sikkim through Bank: Central Bank of India, Account No. 1236133785, IFSC Code: CBIN0282310 in favour of Principal Secretary, Finance Revenue & Expenditure Department, Govt. of Sikkim, Gangtok.

2. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 02- Grants for State Plan Scheme (Sub Major Head), 378 -General-( Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 01 - Multi-sectoral Development Programme for minorities, 01.00.31 - Grant-in-aid general for the year 2014-15.

3. Since it is fresh release, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the date of the Sanction Order.

4. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditions at Annexure-I.




