Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Districts (MCDs) to Government of Uttar Pradesh for the year 2017-18 for Bahraich District.

Sir,

In continuation to this Ministry's sanction letter of even number dated 31.08.2015. I am directed to convey the sanction of the President for release of total amount of Rs. **3,54,36,000/- (Rupees Three Crore Fifty Four Lakh Thirty Six Thousand only)** as 2nd instalment for the year 2017-18 to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Districts" for Bahraich District as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head 49 - Multi sectoral Development Programme for minorities, 49.00.35 Grant for creation of capital assets for the year 2017-18.

3. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.


4. A copy of the Utilization certificate of 1st installment is enclosed. Further it is certified that no UC is pending for this project


6. The State Government should ensure that a board containing information as per Template enclosed as Annexure-III is displayed at the site. After completion of projects, a permanent display would be installed.
