Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration districts (MCDs) to Government of NCT of Delhi for the year 2011-12 for North East Delhi District.

Sir,

In continuation to this Ministry's sanction letter of even number dated 29.03.10 and 14.03.11 and 17.11.11, I am directed to convey the sanction of the President for release of an amount of Rs. 3,52,17,3,80/- (**Rupees three crore fifty two lakh seventeen thousand three hundred eighty only**) (50% of total central share) of the total sanctioned amount of Rs. 7,04,34,750/- (**Rupees seven crore four lakh thirty four thousand seven hundred and fifty only**) for the year 2011-12 to the Govt. of NCT of Delhi for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration districts (MCDs)" for North East Delhi district as per the details enclosed at Annexure -I. The non-recurring grant may be released to the Govt. of NCT of Delhi through cheque in favour of Deputy Director (Minority), Department of Welfare of SC/ST/OBC/Minorities, New Delhi.

2. The State Government is advised to ensure that proportionate share of 50% of state share (i.e. Rs. 117.39125 lakhs) for construction of school buildings is released to the implementing agency alongwith Central share of Rs. 352.17380 lakh.


3. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3602" Grant in-aid to Union Territory Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) - Other Grants, 03 - Multi sectoral Development Programme for minorities in minority concentration districts, 03.00.35 - Grant for creation of capital assets for the year 2011-12.

4. Since it is a fresh release for the revised plan, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount with milestones and time frame, should also be furnished.

5. This sanction would be subject to the condition that the approval of the State Mission Director for RMSA for the proposal is obtained before implementation of the scheme to ensure that there is a need for such a proposal, duplication has been eliminated, specifications and cost norms as prescribed under RMSA guidelines have been followed and the estimates prepared as per SOR of the state government and approved by a competent engineering department. State Govt. should ensure these conditions are met before starting the work. The amount would be scrupulously deducted if any deviation, is found at any stage of the implementation of scheme.
6. Within the one month of the receipt of the release of the amount conveyed through this sanction order, State Govt. will fulfill the commitment required for the project i.e. construction of school buildings at Sunder Nagari and Jafrabad, North East Delhi, Delhi and convey acceptance to all the terms and conditions, failing which the Ministry will review the project.
7. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.
10. This sanction issues with concurrence of IFD vide their Dy. No. 334/2011/IFD dated 17.11.2011 It is noted at S. No. 2 in the Grant-in-aid Register.

5. Utilization of the above mentioned amount by the grantee is subject to the following terms and conditions:

- i. Grantee will maintain a separate account of the funds released by this Ministry under this scheme/programme.
- ii. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
- iii. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
