

Subject: Grant in aid for organizing Orientation Programme under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Blocks to Government of NCT of Delhi for the year 2014-15.

Sir,

I am directed to convey the sanction of the President for release of an amount of Rs. 1,00,000/- (Rupees One lakh only) for the year 2014-15 to the Govt. of Delhi for organizing one Orientation Programme in 1 block, viz; North East in the NCT of Delhi. One Orientation Programme in each block during the year 2014-15. The Programme will be organized for training of the officials concerned and dissemination of required information regarding MsDP. The expenditure for the programme would be on account of preparation of venue, arrangement of Audio-visual instruments, printed material, like, handout, pamphlets, etc., resource persons, vehicles, refreshment and miscellaneous items. A report should be sent to the Ministry along with photographs of the programme. The instructions issued by the Ministry vide letter no.3/32/2012-PP-I dated 16.05.13 and 17.07.13, should also be followed. The non-recurring grant may be released to the Govt. of NCT of Delhi through cheque in favour of Deputy Director(Minority), Department of Welfare of SC/ST/OBC/Minorities, New Delhi.

2. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3602" Grant-in-aid to State Government, 02- Grants for State Plan Scheme (Sub Major Head), 378 -General-(Welfare of Schedule Casts, Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 01 - Multi-sectoral Development Programme for minorities, 01.00.31 - Grant-in-aid general for the year 2014-15.


