4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within 12 months of the closure of this financial year. It is also to be certified by the grantee that no utilization certificate is pending in respect of previous grant/grants.

5. This sanction issues with concurrence of IFD, vide Dy. No. 795/IFD dated 30.06.2015.


