- A copy of the Utilization certificate of 1st installment is enclosed. Further it is certified that no UC is pending for this project.
- Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and the requisitioned amount with milestones and time frame, should also be furnished.

- 10. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at Annexure-II.
- 11. This sanction issues with concurrence of IFD vide their Dy. No. 13/15/2018/IFD dated 26.02.2018. It is noted at S. No. 240 in the Grant-in-aid Register.
