Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for minority concentration district to Government of West Bengal for the year 2012-13 for **Howrah District**.

Sir,

In continuation to this Ministry's sanction letter of number dated 12.12.2008, 30.12.2009, 1.2.2010, 10.3.10, 24/9/10, 27/12/2010, 25/2/11, 30/12/2011, 7/12/2011, 20/03/2012 and 26.03.12, I am directed to convey the sanction of the President for release of an amount of **Rs.7,17,66,000/- (Rupees seven crore seventeen lakh and sixty six thousand only)** as 1st installment (50% of total central share) of the total sanctioned amount of Rs.14,35,30,000/- (Rupees fourteen crore thirty five lakh thirty thousand only) for the year 2012-13 for implementing the scheme "Multi Sectoral Development Programme for minority concentration district" for Howrah district as per the details enclosed at **Annexure I**. The non-recurring grant may be released to the Govt. of West Bengal through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate State share should be released by the State Govt. to the implementing agency alongwith Central share for the projects mentioned at **Annexure -I**.
3. The expenditure is debitible to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) - other grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 - Grant for creation of capital assets.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure -I and also that duplication will not take place.
6. Since it is a fresh release for the revised plan, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount may also be furnished.
7. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP


(Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilization of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.

10. This sanction issues with concurrence of IFD vide their Dy. No.323 dated 09/10/12. It is noted at S. No. 59 in the Grant-in-aid Register.



- iii. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
- iv. Grantee shall not divert any part of the grant to any other activities.
- v. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
- vi. Grantee shall endeavor to achieve the quantified and qualitative targets.
- vii. Grantee will ensure that there is no duplication of work.
