Sir,
In continuation to this Ministry's sanction letter of even number dated 25/6/2009, 24/2/10, 5/3/10, 3/9/10, 30/12/10, 18/2/11 and 30/3/11, I am directed to convey the sanction of the President for release of an amount of Rs. 4,70,70,300/- (Rupees four crore seventy lakh seventy thousand and three hundred) only as 1st instalment (50% of total central share) of the total sanctioned amount of Rs. 9,41,40,600/- (Rupees nine crore forty one lakh and forty thousand and six hunred) only for the year 2011-12 to the Govt. of Bihar for implementing the scheme "Multi Sectoral Development Programme for minorities" for Purnea district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Bihar through CAS, Reserve Bank of India, Nagpur.

- 2. The State Government is advised to ensure that proportionate share of 50% of state share (i.e. Rs. 85.977 lakhs) for the projects mentioned at Annexure-I is released.
- 3. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Central Plan Scheme (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -other grants, 04 Multi sectoral Development Programme for minorities, 04.00.35 Grant for creation of capital assets.
- 4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of the financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount should also be furnished.
- 5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
- 6. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.
- 7. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India. As per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
- 8. Utilisation of the above mentioned amount by the State Government is subject to the terms and condition at annexure-II.
