Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme (MsDP) for **Minority Concentration Blocks/Towns to Government of Maharashtra for the year 2017-18 for Buldana district.**

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs. 1,42,20,000 (Rupees One Crore Fourty Two Lakh Twenty Thousand Only)** as 1st installment to the Govt. of Maharashtra for implementing the scheme "Multi Sectoral Development Programme for **Minority Concentration Town in Buldana** district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Maharashtra through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of State share for the projects mentioned at annexure-I is released to the implementing agency along with Central share.
3. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 49- Multi sectoral Development Programme for minorities, 49.00.35 Grant for creation of capital assets the year 2017-18.
4. Since it is a fresh release for the plan of MsDP, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificate and (iii) Report regarding release of the state share in case of innovative projects may also be furnished.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

7. This is to certify that the present sanction/ expenditure is covered under MEP for the month of Feb, 2017 and Integrated Finance Division (IFD) has approved the expenditure during the Fourth quarter of the financial year 2017-18.

8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.

10. This sanction issues with concurrence of IFD vide their Dy. No.13/26 dated 28/02/2018. It is noted at S. No. 265 in the Grant-in-aid Register.

1. iv. Grantee shall not divert any part of the grant to any other activities.
1. v. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
1. vi. Grantee shall endeavor to achieve the quantified and qualitative targets.
1. vii. Grantee will ensure that there is no duplication of work.
1. viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
