# Subject: Grant-in-aid under the Centrally Sponsored Scheme of Merit-cum Means based Scholarship to the students belonging to minority communities to the Government of Maharashtra for the year 2013-14.

I am directed to convey the sanction of the President for release of non-recurring grant-in-aid of  $\gtrless$  14,43,76,266/- ( $\gtrless$  Fourteen Crore Forty Three Lakh Seventy Six Thousand Two Hundred Sixty Six Only) towards disbursement of 5587 (Five Five Eight Seven) scholarships, both fresh (3721 scholarships) and renewal (1866 scholarships) to the Government of Maharashtra for the year 2013-14 as 100% Central share under the scheme of Merit-cum Means based Scholarships to the students belonging to minority communities, as per details enclosed at Annexure 1 & II. This includes a fund of  $\gtrless$  9,50,000/- ( $\gtrless$  Nine Lakh Fifty Thousand Only) for administrative expenses for the year 2013-14 as per details enclosed at Annexure III. The non-recurring grant may be released to the Government of Maharashtra through CAS, Reserve Bank of India, Nagpur.

2. As per the utilization certificate submitted by the State, they have an unutilized balance of  $\overline{<}$  13,26,186/- ( $\overline{<}$  Thirteen Lakh Twenty Six Thousand One Hundred Eight Six Only) from the previous year's releases from Merit-cum Means based Scholarship scheme. This amount has been adjusted from this release.

3. The expenditure is debitable to Demand No.68 - Ministry of Minority Affairs, Major Head "3<u>601"</u> - Grants-in-aid to State Governments, Sub-Major Head "04"-Grants for Centrally Sponsored Plan Schemes, Minor Head "3<u>78</u>"-General (Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities) - Other Grants, 03 - Merit-cum-Means Scholarship for professional and technical courses for Minorities, 03.00.31 - Grants-in-aid- General for the year 2013-14.

4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within 12 months from the date of this Sanction Order.

5. The State Government/UT Administration should ensure that the sanctioned amount is utilized within one month from the date of crediting of fund in the account of the State.
