Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Districts (MCDs) to Government of Maharashtra for the year 2017-18 for Jalna District.

Sir,

In continuation to this Ministry's sanction letter of even number dated 29.10.2014, I am directed to convey the sanction of the President for release of total amount of **Rs. 1,80,43,000/- (Rupees One Crore Eighty Lakh Forty Three Thousand Only)** as 2<sup>nd</sup> instalment for the year 2017-18 to the Govt. of Maharashtra for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Districts" for Jalna District as per the details enclosed at Annexure-I. The non-recurring grant may be released to the Govt. of Maharashtra through CAS, Reserve Bank of India, Nagpur.

2. The expenditure is debit able to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 49 - Multi sectoral Development Programme for minorities, 49.00.35 Grant for creation of capital assets the year 2017-18.

3. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

4. A copy of the Utilization certificate of 1<sup>st</sup> installment is enclosed. Further it is certified that no UC is pending for these projects.

5. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificate (UCs) and (iii) Report regarding release of the State share in case of innovative projects.

8. Utilization of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.
