Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Blocks and Clusters to Government of **Manipur for the year 2015-16 for Senapati district.**

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs. 10, 26, 48,000** /- (**Rupees ten crore twenty six lakh forty eight thousand only**) as 1st instalment to the Govt. of Manipur for implementing the scheme "Multi Sectoral Development Programme for Saitu Gamphazol, Saikul, Kangpokpi Blocks and Tadubi, Willong, Paomata, Purul and Phaibung clusters in Senapati district as per the details enclosed at Annexure I and Annexure-II. The non-recurring grant may be released to the Govt. of Manipur through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of State share for the projects mentioned at annexure-I is released to the implementing agency alongwith Central share.
3. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 Grant for creation of capital assets the year 2015-16.
4. Since it is a fresh release for the plan of MsDP, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificate and (iii) Report regarding release of the state share in case of innovative projects may also be furnished.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

7. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

8. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.

9. This sanction issues with concurrence of IFD vide their Dy. No 677/IFD dated 29.05.2015. It is noted at S. No 48 in the Grant-in-aid Register.
