Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Districts to Government of Sikkim for the year 2011-12 for North Sikkim District.

Sir,

In continuation to this Ministry's sanction letter of even number dated 17.6.10, 21.1.11, 24.2.11, 31.03.11 and 21.12.11 I am directed to convey the sanction of the President for release of an amount of **Rs.67, 50,000/- (Rupees sixty seven lakh and fifty thousand only)** as 1st installment (50% of total central share) of the total sanctioned amount of Rs.1,34,99,000/- (**Rupees one crore thirty four lakh ninety nine lakh only**) for the year 2011-12 to the Govt. of Sikkim for implementing the scheme "Multi Sectoral Development Programme for minority concentration district" for North Sikkim district as per the details enclosed at Annexure -I.

2. The State Government should ensure that proportionate State share should be released by the State Govt. to the implementing agency alongwith Central share for the projects mentioned at **Annexure -I.**

3. The expenditure is debitable to Demand No.67, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 04- Grants for Centrally sponsored Plan Schemes (Sub Major Head), 378 - General-(Welfare of Schedule Casts/Schedule Tribes and Other Backward Classes) -Other Grants, 04 - Multi sectoral Development Programme for minorities, 04.00.35 – Grant for creation of capital assets for the year 2011-12.

4. The Drawing & Disbursing Officer of the Ministry of Minority Affairs will prepare a bill for **Rs.67, 50,000/- (Rupees sixty seven lakh and fifty thousand only)** to make payment to Principal Secretary, Finance, Revenue & Expenditure Department, Govt. of Sikkim, Gangtok. The amount may be transferred through Bank: Central Bank of India, Branch : Paljor Stadium Road, Gangtok, Sikkim, Account No.: 1236133785, IFSC Code: CBIN 0282310 in favour of Principal Secretary, Finance, Revenue & Expenditure Department, Govt. of Sikkim, Gangtok.

5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure -I and also that duplication will not take place.

6. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount may also be furnished.

The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

9. Utilisation of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II. The amount would be scrupulously deducted if any deviation is found at the stage of the implementation of the scheme.

10. This sanction issues with concurrence of IFD vide their Dy. No 996 IFD dated 29.3.12. It is noted at S. No. 242 in the Grant-in-aid Register.
