- 5. The State Government/UT Administration should ensure that the sanctioned amount is utilized within one month from the date of crediting of fund in the account of the State.
- 6. The State Government is required to furnish monthly return of this expenditure to this Ministry along with a report on amounts outstanding, released to the State Government under Merit-cum Means based Scholarship scheme.
