

Subject: Grant-in-aid under the Centrally Sponsored Scheme of Merit-cum Means based Scholarship to the students belonging to minority communities to the Government of Odisha for the year 2013-14.

Sir,

In continuation to this Ministry's sanction letter of even number dated 16/5/2013, 26/9/2013 & 29/10/2013 for ₹ 6,72,500/-, ₹ 9,89,826/- & ₹11,92,500/-, I am directed to convey the sanction of the President for release of non-recurring grant-in-aid of ₹ **86,79,091/- (₹ Eighty Six Lakh Seventy Nine Thousand Ninety One Only)** as 100% Central share to the Government of **Odisha** for disbursement of funds towards fresh of Merit-cum Means based Scholarship to **310** (Three One Zero) students as per details enclosed at **Annexure**. The non-recurring grant may be released to the Government of **Odisha** through CAS, Reserve Bank of India, Nagpur.

2. No Utilization certificate is pending with the grantee.
3. The expenditure is debitable to Demand No.68 - Ministry of Minority Affairs, Major Head "3601" - Grants-in-aid to State Governments, Sub-Major Head "04"-Grants for Centrally Sponsored Plan Schemes, Minor Head "378"-General (Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities) - Other Grants, 03 - Merit-cum-Means Scholarship for professional and technical courses for Minorities, 03.00.31 - Grants-in-aid- General for the year 2013-14.
4. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within 12 months from the date of this Sanction Order.
5. The State Government/UT Administration should ensure that the sanctioned amount is utilized within one month from the date of crediting of fund in the account of the State.
6. The State Government is required to furnish monthly return of this expenditure to this Ministry along with a report on amounts outstanding, released to the State Government under Merit-cum Means based Scholarship scheme.


