I am directed to convey the sanction of the President for release of recurring grant-inaid of  $\underbrace{1,40,015/-}(\underbrace{\mathbb{Z}}$  One Lakh Forty Thousand Fifteen Only) towards disbursement of 06 (Zero Six) scholarships, both additional fresh (01 scholarship) and renewal (05 scholarships) to the UT Administration of Puducherry as 100% Central share under the scheme of Meritcum Means based Scholarships to the students belonging to minority communities, as per details enclosed at **Annexure 1 & II**. 6. The State Government is required to furnish monthly return of this expenditure to this Ministry along with a report on amounts outstanding, released to the State Government under Merit-cum Means based Scholarship scheme.
