Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme (MsDP) for **Minority Concentration Blocks/Towns** to **Government of Uttar Pradesh for the year 2017-18 for Rampur district.**

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs. 4,14,76,500 (Rupees Four Crore Fourteen Lakh Seventy Six Thousand Five Hundered Only)** as 1st installment to the Govt. of Uttar Pradesh for implementing the scheme "Multi Sectoral Development Programme for **Minority Concentration Town** in **Rampur** district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of State share for the projects mentioned at annexure-I is released to the implementing agency along with Central share.
3. The expenditure is debitable to Demand No.66, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 49- Multi sectoral Development Programme for minorities, 49.00.35 Grant for creation of capital assets the year 2017-18.
4. Since it is a fresh release for the plan of MsDP, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificate and (iii) Report regarding release of the state share in case of innovative projects may also be furnished.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

7. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
8. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.
9. This sanction issues with concurrence of IFD vide their Dy. No. 13/255 dated It is noted at S. No. 183 in the Grant-in-aid Register.

1. i. Grantee will maintain a separate account of the funds released by this Ministry under this scheme/programme.
1. ii. The expenditure incurred by the grantee shall be open for inspection by the sanctioning authority/ Comptroller & Auditor General of India/Internal Audit by the Chief Controller of Accounts of the Ministry of Minority Affairs.
1. iii. The grantee will ensure that it has not obtained or applied for grants for the same purpose or activity from any other Ministry or Department of the Government of India or State Government.
1. iv. Grantee shall not divert any part of the grant to any other activities.
1. v. Grantee shall be governed by all the terms and conditions of the grant as prescribed in the scheme/programme and in GFR.
1. vi. Grantee shall endeavor to achieve the quantified and qualitative targets.
1. vii. Grantee will ensure that there is no duplication of work.
1. viii. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
