Indira Awas Yojana

- (a) The State will ensure that 20 BPL families per village in 50 villages per block having the highest proportion of minority population would be selected.
- (b) The State Government will ensure that IAY guidelines for selection of beneficiaries would be followed and BPL families figuring in the wait list, even if they belong to communities other than the minority communities, would be selected in order of their ranking in the list.

Construction of additional Class Rooms (ACR) in lower primary and middle schools.

- (a) The proposal was approved by the Empowered Committee subject to condition that the proposal is as per the norms of Sarva Shiksha Abhiyan and on the assurance that duplication would not take place.

Instalation of Tara Hand Pump.

- (a) The State Govt. will ensure that it will be distributed in villages of all blocks which are sourceless and have the highest proportion of minority population.
