

**Subject: Grants-in-aid for the purpose of Administrative Expenses to the State Government of Tamil Nadu for the year 2014-15.**

Sir,

I am directed to convey the sanction of the President for release of recurring grant-in-aid of ₹ 22,78,749/- (₹ **Twenty Two Lakh Seventy Eight Thousand Seven Hundred Forty Nine Only**) as 100% Central Share to the Government of **Tamil Nadu**, for implementation of the Scheme of Merit-cum Means based scholarship for students belonging to the minority communities, for the year 2014-15 for the purpose of Administrative Expenses.

2. The recurring grant may be released to the Government of **Tamil Nadu** through CAS, Reserve Bank of India, Nagpur.
3. No Utilization certificate is pending with the grantee.
4. The expenditure is debitable to Demand No.68 - Ministry of Minority Affairs, Major Head "3601" - Grants-in-aid to State Governments, Major Head "03"-Grants for Central Plan Schemes (Sub-Major Head) "377"-General (Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities) - Other Grants (Minor Head), 09 - Merit-cum-Means Scholarship for professional and technical courses for Minorities, 09.00.31 - Grants-in-aid- General for the year 2014-15 (Plan).
5. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format (GFR 19-A) within 12 months from the date of this Sanction Order.
6. The State Government should ensure that the sanctioned amount is utilized within one month from the date of crediting of fund in the account of the State.
