Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Blocks to Government of **Arunachal Pradesh for the year 2015-16 for West Siang District.**

Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs. 1,73,00,000/- (Rupees one crore seventy three lakh only)** as 1<sup>st</sup> instalment for the year 2015-16 to the Govt. of Arunachal Pradesh for implementing the scheme "Multi Sectoral Development Programme for Minority Concentration Blocks (MCB), Mechuka Block, Basar Block and Kaying Payum Block in West Siang district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of Arunachal Pradesh through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of 50% of State share for the projects mentioned at annexure-I is released to the implementing agency alongwith Central share.

3. The expenditure is debitable to Demand No.68, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 02- Grants for State Plan Schemes (Sub Major Head), 378 -General- (Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 Grant for creation of capital assets the year 2015-16.

4. Since it is a fresh release for the plan of MsDP, no UC is pending. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 8.4 of the guideline of Restructured Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Utilization Certificate and (iii) Report regarding release of the state share in case of innovative projects may also be furnished.

5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.

7. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.

8. Utilization of the above mentioned amount by the State Government is subject to the terms and conditions at annexure-II.

9. This sanction issues with concurrence of IFD vide their Dy. No 1187 /IFD dated 22.09.2015 . It is noted at S. No. 219 in the Grant-in-aid Register.
