Subject: Grant in aid under the Centrally Sponsored Scheme of Multi sectoral Development Programme for Minority Concentration Districts (MCDs) to Government of NCT of Delhi for the year 2014-15 for North East Delhi District.

Sir,

In continuation to this Ministry's sanction letter of even number dated 25.03.2013 I am directed to convey the sanction of the President for release of an amount of Rs. 1,14,92,750/- (Rupees one crore fourteen lakh ninety two thousand seven hundred and fifty only) as 2<sup>nd</sup> instalment for the year 2014-15 to the Govt. of NCT of Delhi for implementing the scheme "Multi Sectoral Development Programme for minority concentration districts" for North East Delhi district as per the details enclosed at Annexure I. The non-recurring grant may be released to the Govt. of NCT of Delhi through cheque in favour of Deputy Director (Minority), Department of Welfare of SC/ST/OBC/Minorities, New Delhi.

2. The State Government should ensure that proportionate share of State share for the projects mentioned at annexure – I is released to the implementing agency alongwith Central share.
3. The expenditure is debitible to Demand No.68, Ministry of Minority Affairs Major Head- "3602" Grant-in-aid to Union Territory Governments (Major Head), 02- Grants for Union Territory Plan Schemes (Sub Major Head), 378 -General-(Welfare of Scheduled Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 01 - Multi sectoral Development Programme for minorities, 01.00.35 Grant for creation of capital assets the year 2014-15.
4. A copy of the Utilization certificate of 1<sup>st</sup> installment is enclosed. Further it is certified that no UC is pending for this programme.
5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be selected for the projects mentioned at Annexure-I and also that duplication will not take place.
6. Utilization Certificate for this grant should be submitted by the grantee in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 15.4 of the guideline of Multi sectoral Development Programme, (i) Quarterly Progress Report, (ii) Photographs of the works completed from earlier releases and (iii) work plan for the requisitioned amount with milestones and time frame may also be furnished.
7. The State Government should ensure that a board containing information of the date of sanction of the project, likely date of completion, estimated cost of the project, source of funding i.e. MsDP (Government of India), contractor(s) name and the physical target is displayed. After completion of projects, a permanent display would be installed.

9. Utilization of the above mentioned amount by the State Government is subject to the terms and conditioned at annexure-II.
