4. The release of funds is subject to fulfillment of the terms and conditions prescribed under the scheme guidelines, Memorandum of Understanding (MOU) signed between Ministry and organization and Bond furnished by the organization.
5. The organization shall guarantee Placement to all trained minority youths under this scheme with a minimum placement of 75% candidates and at least 50% out of them in organized sector.
6. The organization will provide Post Placement Support for period of one year and develop Management Information System as per scheme guidelines.
7. No UC is pending in the Ministry in respect of Orion Edutech Pvt. Ltd.
8. The organization shall ensure commencement of project within 15 days of sanction of first installment and furnish list of trainees in the format prescribed.
9. The organization will submit the Progress Report and Utilization Certificate in GFR 19 (A), as prescribed in para 7 of the Scheme Seekho Aur Kamao.
10. Re-appropriation Rs. 1,58,40,000/- (Rupees One Crore Fifty Eight Lakh Forty Thousand only) from Major Head 2552 to Major Head 2235 has been carried out with the approval of Secretary (MA) vide Dy. No. 1921 dated 10.12.2013.
